MESSAGE FROM THE PRESIDENT

Convening in Exhilarating, Incomparable Chicago

This is where I tell you about Chicago in hopes of convincing you to come to the conference. But how do you describe, in a few words, a city that is just....so much! I am an unabashed fan of Chicago. I have visited it many times and don't recall a single bad moment there. Even the mundane, like commuting across town, can be interesting or entertaining in Chicago.



Pulitzer Prize-winning novelist Norman Mailer called Chicago "The Great American City." He wasn't wrong. Another Pulitzer Prize-winning journalist, biographer, and poet, Carl Sandburg, called Chicago the stormy, husky, brawling, city of the Big Shoulders...and Carl really knew Chicago. Regardless of what nickname you use or adjective you choose, no word seems quite enough to describe Chicago.

Simply saying "Chicago" should be enough to get you to the conference. If not, the host hotel for the conference is The Pendry Chicago, a luxury boutique hotel with everything you could ever ask for, including two great restaurants—and one is outdoors on a rooftop. The Pendry fills an Art Deco architectural masterpiece that was known as the Carbide and Carbon Building when it was erected in 1929. It's set downtown amid soaring skyscrapers and is located right in the heart of the Loop. (The Loop is a vibrant area featuring eclectic eateries, shops, theaters, and parks.) Not only is The Pendry in The Loop, it sits at 230 N. Michigan Avenue on Chicago's Magnificent Mile, near numerous museums, Millennium Park, and just a block from the Chicago River. Conference attendees receive a special rate of only \$187 plus tax (the federal per diem for Chicago) on reservations made prior to July 14, 2022.

Under the direction of Vice President Peter Halbach (ND), the curriculum for the Conference is impressive. It is structured to deliver a wide array of educational courses on general administrative law topics and specialized subjects for particular areas of practice. Topics include, but are not limited to, bench skills, credibility assessment, due process, ethics, hearing safety and security, implicit bias, hearing conduct and control, decision writing, evidence (basic and advanced), managing hearings with self-represented litigants, leadership skills, diversity, equity and inclusion, hearsay, qualifying expert witnesses, and how to create instructional presentations for adult learners

NAHO strives to provide quality faculty. Conference instructors include professors who are recognized experts in administrative law, appellate judges, knowledgeable attorneys, and experienced adjudicators. The full conference schedule and faculty bios will be posted on the NAHO website soon!

Some great activities planned for the conference including a cruise on the Chicago River and a trip to historic Wrigley Field to see the Washington Nationals take on the Chicago Cubs. The conference registration fee includes the Sunday evening Welcome Reception, the Monday keynote luncheon, and the annual Appreciation Luncheon on Wednesday.

Our host hotel, the Pendry, is at 230 Michigan Avenue on Chicago's Magnificent Mile—one of the great avenues in the world and an international tourist destination. The famed mile encompasses 460 stores, 275 restaurants, 60 hotels, and dozens of unique parks, museums, galleries, and other activities and attractions packed and stacked along its length, which takes you to Chicago's scenic lakefront.



Our hotel is a block from the Chicago River and the Chicago Riverwalk a 1.25-mile public walking path in Chicago's vibrant riverfront, dotted with parks, architectural and historical sights, dining, and outdoor activities.

MAKING YOUR HOTEL RESERVATIONS

The Pendry Hotel Chicago offers NAHO conference attendees a discounted rate of \$187.00 per night based on the per diem set by the General Services Administration. This rate is subject to applicable state, county, and city taxes (17.4%), which may change without notice based on state and local laws. Located at 230 Michigan Avenue, the hotel offers contemporary, comfortable rooms within the iconic 1929 Art Deco Carbide and Carbon Building in Chicago's Loop.


The deadline to receive this conference rate for your hotel room is Thursday, July 14th, 2022. After July 14th, guestrooms may or may not be available and if available, will be at the hotel's prevailing rate.

NAHO conference attendees can receive NAHO's special discounted rate for lodging up to three days prior to the conference and up to three days following the conference depending on availability. There is a 24 hour cancellation policy. To confirm a sleeping room within the NAHO Room Block, reservations must be secured with a valid credit card. You may cancel your room up to 24 hours in advance of the scheduled arrival date without penalty. Cancellations made less than 24 hours before arrival will be charged the cost of one night's lodging plus taxes.

NAHO's guaranteed room block for the conference is limited, so please make your reservations early!



FROM CHICAGO O'HARE INTERNATIONAL AIRPORT

The Pendry Hotel Chicago is located at 230 Michigan Avenue, however, only transit buses are allowed to stop on the Michigan Avenue side of the hotel. **The address for shuttle drivers, taxis, Uber, or Lyft is the drop-off point on the north side of the hotel, 81 East Wacker Place.** The driving distance to the hotel from Chicago O'Hare International Airport is 40 miles can take up to an hour, depending on traffic.

GETTING TO THE HOTEL FROM CHICAGO O'HARE INTERNATIONAL AIRPORT

The least expensive way to get to downtown Chicago is with Chicago Transit Authority subway, locally referred to as the "L." It will take you all the way from O'Hare to downtown in about 42 minutes for about \$5.00. You can catch the Blue Line, which runs from Terminals 1, 2, and 3 every ten minutes, by just following the signs posted at the airport that say "CTA Trains" or "Trains to the City." The Blue Line trains run 24/7. From the Bue Line stop nearest the hotel, at W. Washington and N. Dearborn, it's about a nine-minute walk to the hotel.

You can also reach downtown by taking the subway to the Jefferson Park Transit Center and catching the Line 56 bus, which runs every 20 minutes, for around \$8. The nearest bus stop to the hotel is at Washington and Wabash. From there, it's a six-minute walk to the hotel.

GO Airport Shuttle (\$30) services downtown Chicago hotels and departs from the O'Hare every 10 to 15 minutes 24 hours a day. GO Airport Shuttle is limited to passengers who have only one bag and only one carry-on. The cost is \$30 per person and the trip takes 45 to 60 minutes.

The prices for O'Hare's Airport Supersaver Shuttle start at \$19, and customers are permitted up to 2 bags for free, but additional bags may cost extra. They offer drop-offs in several locations, but the duration of the trip can take from one to four hours, depending on the number of drop-offs they must make before arriving at your hotel. The shuttle is available daily, but not quite 24 hours.

The pick-up point for any shuttle leaving O'Hare is just outside the baggage claim area at Door 1E for Terminal 1, Door 2E for Terminal 2, Door 3E for Terminal 3, and Door 5E for Terminal 5.

Taxis are also available just outside the terminal. The fare will be approximately \$50 plus tip and the driving time is 35 to 55 minutes, depending on traffic. If you choose to travel with one additional passenger, there is a flat rate of \$24 per person for shared taxis.

You can also use Uber or Lyft to get from O'Hare to downtown Chicago for about \$45 ordinarily. If traffic is heavy and the trip takes a long time, the cost can go up to \$75. To reach their pickup point from the terminal, just follow the signs directing you to "Rideshare Pickup." Remember that the drop-off point for the Pendry is at 81 East Wacker Place on the north side of the hotel.

GETTING TO THE HOTEL FROM CHICAGO MIDWAY INTERNATIONAL AIRPORT (Delta and Southwest Airlines)

The driving distance to the Pendry Hotel at 230 Michigan Avenue is 37 minutes (22 miles).

The least expensive way to get to downtown Chicago from Midway is with the Orange Line subway train or "L." It will take you all the way from Midway to downtown in about 30 minutes for about \$5.00. The Orange Line train runs from 4:00 a.m. to 1:00 a.m. daily. The fully-accessible Midway station is located just east of the airport terminal building at the Midway Transportation Center and is connected to the airport via an enclosed walkway. Follow the signs in the airport that read "CTA Trains" or "Trains to City" to reach it. From the Orange Line stop nearest the hotel, at State and Lake, it's about an eight-minute walk to the hotel.

Chicago Transit Authority buses also pick up and drop off at the same Midway Transportation Center that services the Orange Line subway. The route name for the downtown bus is 62N, which is also called the Archer route.

GO Airport Express Chicago provides door-to-door shared ride airport shuttle service with SUVs, as well as private car service to Midway Airport. Shuttles depart from Midway Airport every 15 minutes for service to downtown Chicago hotels. In Midway, GO Airport Express ticket counter and loading zone is located at Door 3, located on the lower level across from baggage claim. Reservations are not necessary.

Taxis, Uber, and Lyft are also available at Chicago Midway. Just follow the signs.

■ NAHO MEMBERSHIP

■ NAHO CERTIFICATION

The National Association of Hearing Officials is the only national professional organization for administrative hearing officials that offers a certification program for hearing officers and administrative law judges.

The NAHO certification program is dedicated to developing uniform standards of excellence and professionalism for hearing officers and administrative law judges across the country. Course requirements for certification ensure that individuals have a sound background in administrative law and hearing procedures. Certification stands as tangible evidence of your personal commitment to your own professional development and to a fair hearing process. NAHO membership is required for certification. Courses attended at this year's conference may be considered towards meeting certification requirements for 2022. Core requirements can be met by attending NAHO webinars, virtual and in-person NAHO conferences, viewing instructional videos of past webinars and conference classes via the NAHO Library, through courses completed at the National Judicial College, and by participating in other recognized programs addressing the administrative hearing process.

CLE ACCREDITATION
