## 2022 NAHO Annual Professional Development Conference

#### <u>A Summer Conference</u>

NAHO is offering its annual conference at a new time this year, **August 7 – 10**, **2022**. It's a time when work might slow a bit and NAHO members and others involved in the administrative hearing process can take a little time to get some training – and bring family or friends along for some fun in Chicago!



A Great Venue The Conference will be held at the historic Pendry Hotel at 230 N. Michigan Avenue in Chicago, Illinois. One of the best examples of Art Deco architecture in the nation, the hotel is part of Chicago's Magnificent Mile. Only steps away from the famous



shopping district, a block from the Chicago River and only a few blocks from Millennium Park, attendees will also be able to enjoy numerous museums, bistros and restaurants that are within easy walking distance. The hotel has two excellent restaurants, including one on the 24th floor with alfresco rooftop dining.

The special hotel rate for Conference attendees, which will be in effect until July 14, 2022, is **\$187.00 plus 18% tax per night.** This rate will be honored beginning on August 3 and run until August 13, depending on availability. Attendees will have a chance to enjoy Chicago before and after the Conference. Make sure you tell the hotel you are with the NAHO Annual Professional Development Conference to be sure to get this rate.



### Time for Fun

The Conference will have a "soft opening" on Sunday, with a training session followed by an optional two-hour lunch or brunch cruise that will depart from the Chicago Navy Pier, which is an easy walking distance from the hotel. ### Of Course, Our Courses are the Main Event

The Conference will provide keynote and luncheon speakers and sessions on the latest issues in administrative law, including ethics, recognizing and reducing implicit bias, best practices for conducting hearings, decision writing, basic and advanced issues in evidence, and many more valuable topics. NAHO will again offer three different classes for each hour of the Conference; attendees may choose from over 50 different topics, attaining up to 18 hours of MCLE credits over the three-day Conference.

NAHO instructional presentations are designed for ALJs and other administrative adjudicators, Chief ALJs, Board or Commission Members, attorneys whose practice involves administrative law and hearings, and agency administrators and representatives who wish to expand their knowledge of the process of administrative adjudication. NAHO's quality faculty includes law professors recognized as experts in administrative law, appellate judges, attorneys, and experienced practitioners in administrative hearings and law.
